Spring Hill College's crime prevention and security programs nurture the personal growth of students with the goal of assisting students to develop into responsible citizens consistent with the teachings and traditions of Spring Hill College as a Jesuit, Catholic institution.

<u>Summary Description</u>: This is a full-time, fiscal year position reporting to the Associate Vice President for Culture and Community. The Chief of Police and Public Safety is responsible for planning, organizing, implementing, and directing the law enforcement and public safety functions of Spring Hill College. Serves as the Chief law enforcement officer of the College responsible for protecting life and property, enforcing all state and local laws and college regulations, preventing crime, and preserving order. Responsible for campus wide safety and security policies and procedures.

Description of Duties/Responsibilities:

Essential Functions

- 1. Serve as the main contact for the college and campus community relating to matters of public safety and law enforcement
- 2. Oversee and ensure the effective planning, organizing, staffing, directing, coordinating and budgeting of the department.
- 3. Oversees all college police and public safety operations, threat assessment, compliance, reporting and emergency response through crime prevention activities, patrols, investigations and community policing

4. Ensure all officers and staff maintain required certification and mandatory training hours 5. Coordinate maintenance of police vehicles and the property room for storage of weapons, contraband, etc..

- 6. Custodian of criminal reports, incident reports, investigative reports, traffic accident reports and arrest record information
- 7. Ensure that the department follows federal and state laws related to law enforcement and college compliance standards
- 8. Collaborate with campus partners to develop campus outreach, education, and prevention programs related to public safety

- 9. Establish, maintain and cultivate liaisons with college departments, police chiefs, local law enforcement agencies, emergency managers and the surrounding community
- 10. Prepare and publish all reports required by local, state, federal agencies

11. Develop, coordinate and manage Public Safety's response to special events on campus 12. Manage all vehicular traffic related programs to include traffic flow, traffic and parking signs, campus parking, vehicle decal program, violation notices, and fine collection compliance process 13. Performs duties of police and security officers as needed.

14. Be available for on call needs 24/7

15. Other additional duties as assigned

Required Knowledge, Skills, and Abilities:

- 1. Familiarity with or sincere interest in learning about the mission of Spring Hill College and the meaning of a Jesuit education, thus enabling the employee to support and strengthen the Jesuit, Catholic mission of Spring Hill College.

3. Ability to plan, organize and administer a comprehensive police program. 4. Strong interpersonal skills and ability to build strong relationships and trust with students, faculty, staff and community to allow for open communication.

- 6. Must be able to carry out physical activities of law enforcement and public safety; able to perform duties on foot and vehicle.as needed.
- 7. Working knowledge of Jeanne Clery Disclosure of Campus Security and Campus Crime Statistics Act, Title IX, OSHA regulations and Alabama Fire Code.
- 8. Computer technical skills; ability to prepare computer generated reports in timely manner 9. Knowledge of laws, legal codes, court procedures, precedents, government regulations, executive orders, and the democratic political process.
- 10. Demonstrated analytical and problem-solving skills
- 11. Excellent verbal, written, and interpersonal communications skills.
- 12. Ability to react quickly and calmly in emergency situations and to determine proper course of action.

13. Ability to enforce laws firmly, tactfully and with respect for the rights of others. 14. Ability to lift and transport objects or equipment weighing up to 50 pounds, including traffic barricades and fire extinguishers.

- 15. Ability to stand for long periods of time.
 - 16. Trained in cultural competencies, appreciate a variety of diverse characteristics and are committed to the mission of providing professional law enforcement, effective emergency response, crime & incident reduction and community outreach & education.
- 17. Ability to successfully complete CPR, Basic First Aid, and AED training.

Current certification for Adult/Child cardiopulmonary resuscitation (CPR), First Aid and Automatic External Defibrillators (AED) is required.

Other Qualifications: Must be willing to submit to background checks and all applicable drug testing.
